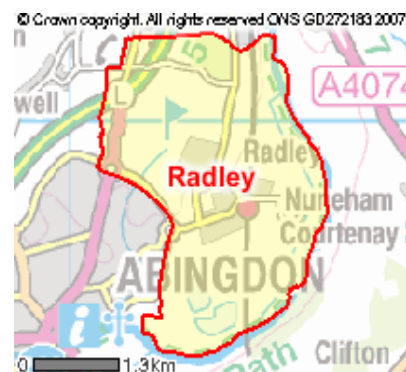


RADLEY in numbers

This summary gives a numerical profile of the people living in Radley. All the numbers presented here are for Radley ward. Centred on the village, the ward extends to Peachcroft Farm and Lodge Hill in the west, to Radley Big Wood in the north (including the mobile home parks of Woodlands, Pebble Hill and Bigwood), whilst the eastern and southern boundaries follow the River Thames towards Abingdon. The ward boundary is the same as the parish boundary.



Population

Radley is home to **3,200 people**, including almost 700 boys between the ages of 13 to 18 years boarding at Radley College. The population has increased by 450 (16%) since 2001 (Table 1).

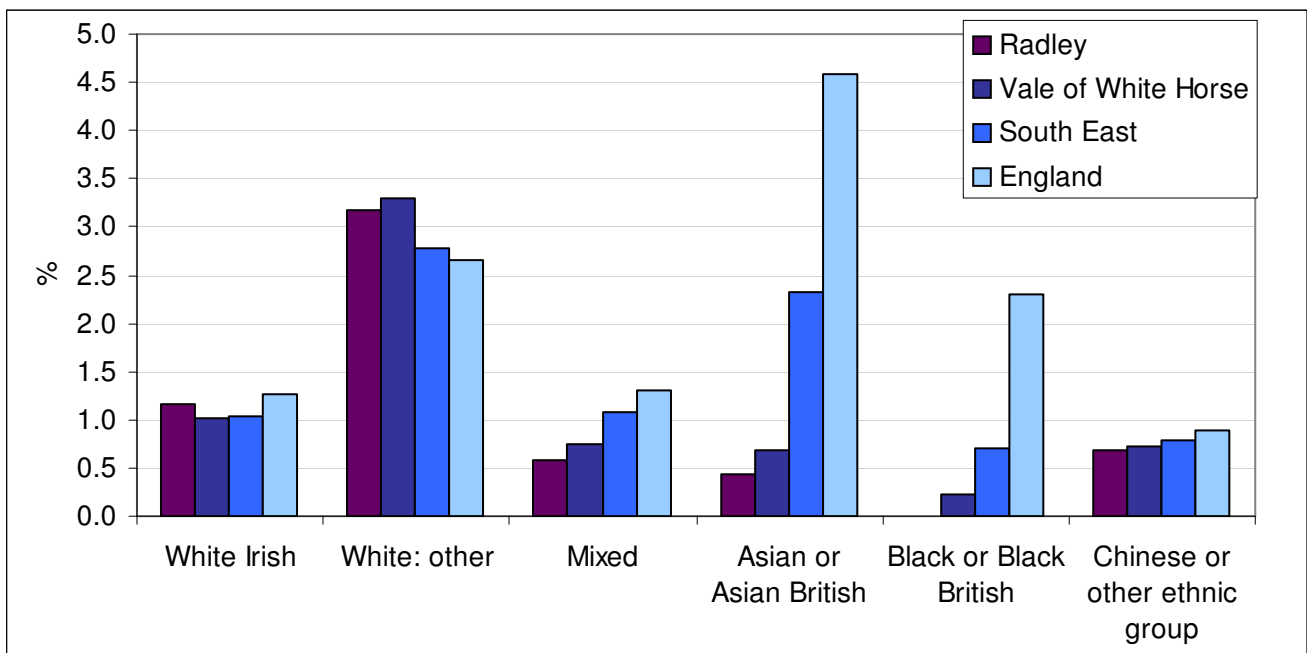
Figure 1 Radley population profile, 2009

Radley has a higher percentage of 65-74 year olds than average for the Vale of White Horse district, and a smaller proportion of children from birth to 9 years. (Figure 1)

The majority of people living in Radley are White British (94%), and 78% of residents state their religion as Christian (Figure 2, Table 2).

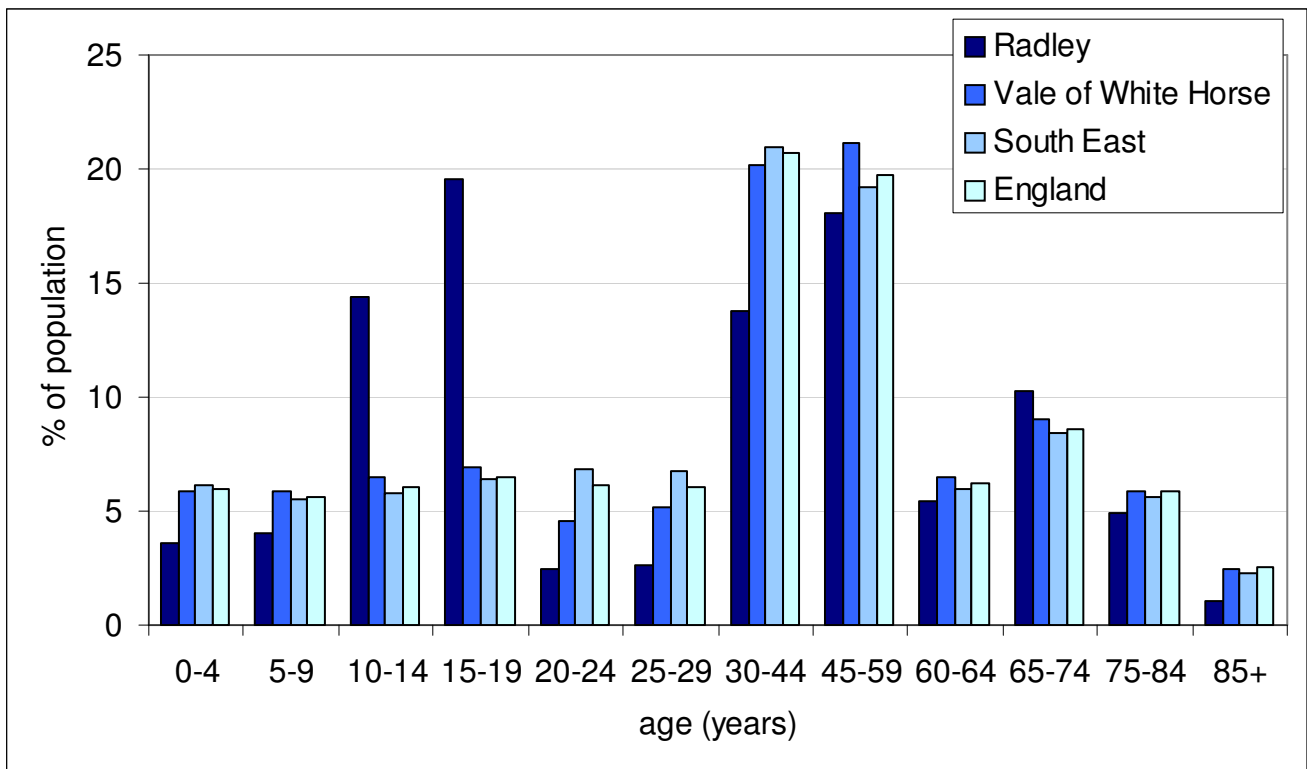

Health

Three quarters of residents in Radley are in good health, with 6% of the population stating they were in poor health (Table 3). 360 people (13%) stated they had a long term limiting illness¹ (2001 Census). In 2009, 0.3% of residents claimed disability allowance (Department of Work and Pensions, 2009).

8% of residents provide voluntary care to support family, friends or neighbours experiencing problems due to physical or mental health, disability or old age (Census 2001).

Employment and qualifications

59% of residents in Radley aged between 16-74 years are economically active, 85% of these as employees and a further 13% self-employed.

41% are economically inactive, compared with 27% in Vale of White Horse and 33% nationally. This figure includes a high number of students (the majority pupils at Radley College aged between 16-18 years), as well as a higher than average percentage of retired people (table 4).

Radley has a higher percentage of people in professional occupations than average across the Vale of White Horse district (Table 5), but also has an above average number of people with no qualifications (Figure 3).

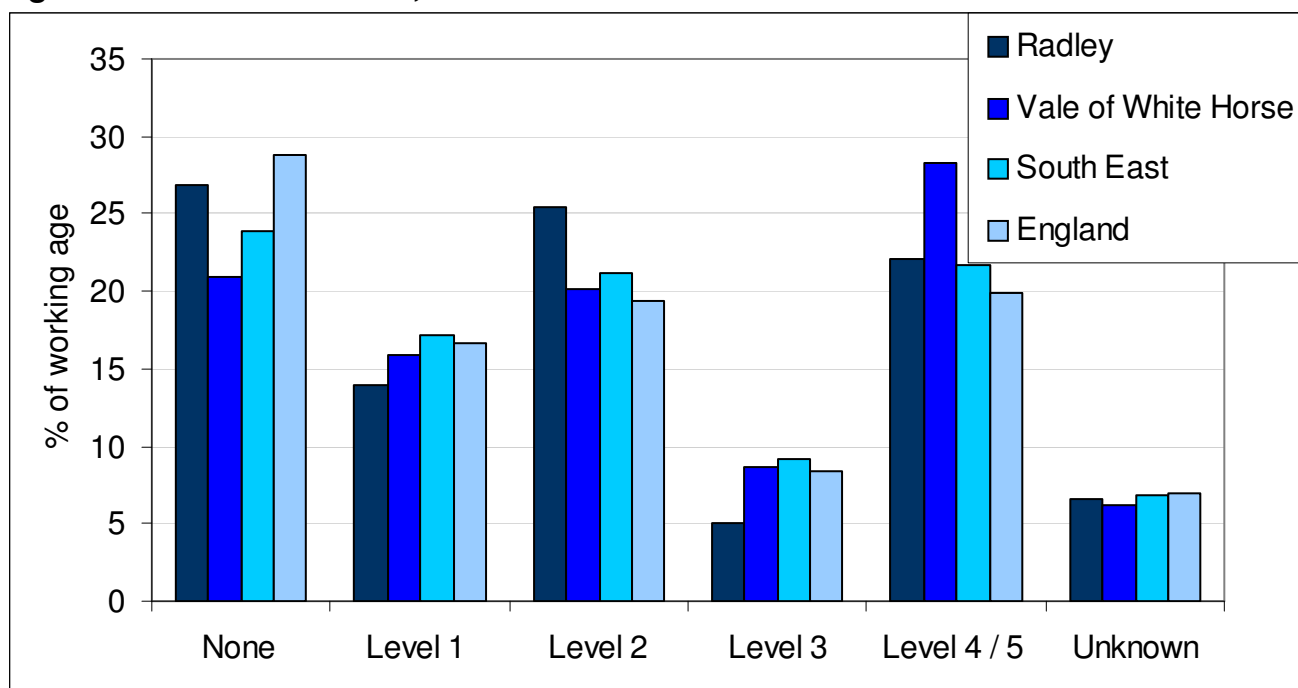

Unemployment

At the beginning of August 2011, less than 2% of Radley's working age population² were claiming job seekers allowance, well below the national average (Table 6). The proportion of long-term unemployed was well below the district and national averages (Table 7).

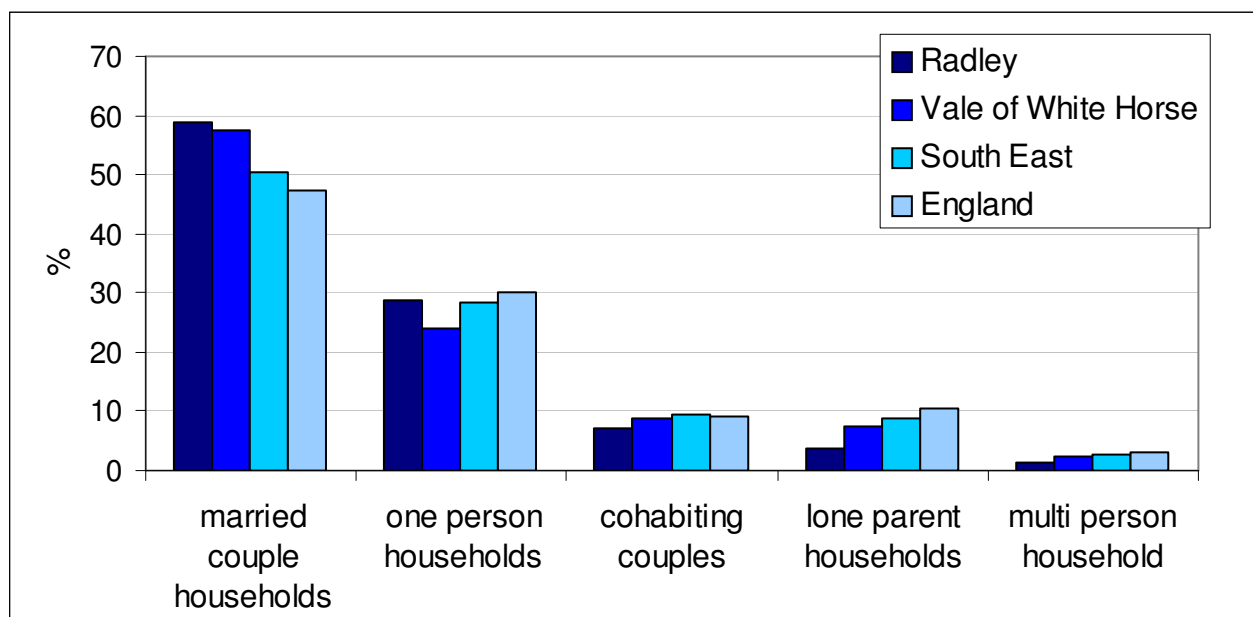

Households and dwelling stock

In 2001, there were 933 households in Radley. Almost 60% of these are married couple households, above the regional and national average (Figure 4), whilst 30% are single person households, around half of which are occupied by older people living alone. Since 2001 the number of households is estimated to have increased to 963³

Almost half of the households are owned outright, well above the district, regional and national averages (Table 8).
